Government Related to Census 2020 Outreach Activities.

CLA RECOMMENDATION: Adopt Resolution (Wesson-Price) to include in the City's 2017-2018 State Legislative Program, SUPPORT for legislation or administrative action that would contribute more funding to local government Complete Count Committees and related census outreach activities.

SUMMARY

Resolution (Wesson-Price), introduced March 23, 2018, notes that the Decennial Census is one of the key functions of the US government, and is essential for government agencies, private businesses, and research professionals serving the US population. A lack of adequate funding would adversely affect the City's representation in Washington, D.C., and millions of dollars in State and federal funding. The City of Los Angeles has prioritized Census education and outreach for at least 30 years. Efforts in the 1990, 2000, and 2010 censuses sought to ensure that every resident in the City was counted by the Census Bureau. The Resolution notes that the Governor's 2018-2019 budget would allocate funds for a California Complete Count Committee to provide education programs. The Resolution recommends that the City support legislation that would also provide funds for local Complete Count Committees.

BACKGROUND

The U.S. Census Bureau conducts a census of the nation's population every ten years in order to provide an accurate population count and demographic information of residents of the U.S. The next census will occur on April 1, 2020.

To assist with preparation for the 2020 Census, the 2017-2018 California State Budget allocated \$3 million for 2020 Census outreach planning, as well as \$7 million toward local assistance for the Local Update of Census Address Program (LUCA). The funds for LUCA allowed local governments to review and revise the U.S. Census Bureau's address list for local jurisdiction prior to the 2020 Census. The LUCA Program helps ensure accurate census results by providing all addresses in a jurisdiction, which results in those addresses receiving census information.

A Complete Count Committee is a volunteer committee established by tribal, state, and local governments, and/or community leaders, to increase awareness about the census and motivate residents in the community to respond. Complete Count Committees are funded through state government, local government, or community-sponsored allocations.

California Complete Count Committee

The 2020 California Complete Count Committee, as appointed by Governor Brown on April 13, 2018, is a statewide panel of community members that will guide California's outreach for the 2020 federal census. The California Complete Count Committee's responsibilities include allocating State funds for the implementation of the Census 2020, developing an action plan identifying targets for outreach, and coordinating activities with local Complete Count Committees throughout the State.

Los Angeles Complete Count Committee

The City of Los Angeles's Complete Count Committee, coordinated by the Office of the Mayor, is working in partnership with the County to conduct a countywide outreach and education campaign. Their outreach strategy includes:

- Establishing Census Action Kiosks in City facilities.
- Establishing a Census Goodwill ambassadors program to inform, educate and mobilize citizens about Census 2020.
- Combining Complete Count Committees with the County to avoid duplication of efforts.
- Developing a countywide communication and marketing plan.
- Utilizing the County of Los Angeles Low Response Mapping Tool to help identify hard-to-count populations.

Funding Increase for Local Governments

The proposed 2018-2019 California State Budget allocates \$40.3 million dollars over the next two years for Census 2020, with \$3 million set aside for all local governments to develop and implement Complete Count Committees. However, the County of Los Angeles testified before the State Senate Budget Committee requesting \$8.7 million be allocated to the County of Los Angeles for countywide outreach, which would include the City of Los Angeles' Complete Count Committee's outreach needs.

MOTION

On March 26, 2018, the California Attorney General sued the United States Commerce Department to block the implementation of a new policy to ask respondents to the Census whether or not they are U.S. Citizens.

Such a question might have the effect of chilling participation in the Census by non-citizens and therefore undercount the populations of states like California and many, if not most, neighborhoods in Los Angeles. Many federal funding programs allocate resources to the various states and cities throughout the United States based on population. Asking the question of citizenship is designed not to get an accurate count of the nation's population, but to redirect federal funding away from densely populated areas with greater need towards less-densely populated areas with need that is not as great.

SUMMARY

The State of California Department of Finance has provided funding for local governments to respond to the U.S. Census Bureau's local Update of Census Addresses (LUCA) program. The City is eligible to apply for \$125,000 to offset costs associated with LUCA. The Bureau of Engineering (BOE) is the City's designated LUCA program office and should be authorized to apply for and receive these funds.

DISCUSSION

In November 2017, the California Department of Finance (Finance) released a memorandum titled "Opportunity to Receive State Funds for Local Governments Who Participate in the LUCA Program," which referenced the United States Census Bureau's Local Update of Census Addresses (LUCA) program. The memo notes that LUCA provides local governments an opportunity to review the housing and group quarters mailing addresses used by the Census Bureau to conduct the 2020 Census. Full participation by California cities and counties will identify errors in the Census Bureau's address lists and improve the count of California residents.

The memorandum further states that the 2017-18 Governor's Budget established an incentive fund to encourage cities and counties to participate in the LUCA program and to help mitigate some of the cost of that participation. The amount earmarked for the City of Los Angeles is \$125,000, which is based on the housing activity from April 1, 2010 to January 1, 2017 using estimates from the Demographic Research Unit.

In preparation for the 2020 Census, the Bureau of Engineering (BOE) is responsible for cleaning, preparing, processing, and matching the data required to complete LUCA. Therefore, the \$125K the State has earmarked to incentivize LUCA participation should be provided to BOE to assist with this important task.

Finance is responsible for administering the LUCA incentive fund, which requires a local government to: (1) register to participate in the LUCA program with the U.S. Census Bureau by December 15, 2017; (2) Participate in the LUCA Program and submit required materials

provided to the Census Bureau, which will be distributed to localities in the first quarter of 2018; and (3) request incentive funds from Finance once LUCA instructions have been received from the Census Bureau.

As of January 30, 2018, Los Angeles has completed number (1) above and is waiting to receive the materials from the Census Bureau to complete task number (2).

The City has historically operated a robust LUCA program, using data from a wide range of City databases to ensure that the LUCA address list is complete and accurate. Census data are used to determine the distribution of members of the House of Representatives, as well as draw district boundaries for Federal, State, and local offices. These data are also used to allocate hundreds of millions of Federal, State, and local dollars including transportation and health services. A full and accurate census is essential to ensure that City residents receive fair representation and that the City receive its fair share of funding to operate its programs.

RECOMMENDATIONS

That the City Council:

- 1. AUTHORIZE the Bureau of Engineering, with the assistance of the Chief Legislative Analyst, to seek a grant in the amount of \$125,000 from the California Department of Finance for the US Census Local Update of Census Addresses and deposit this amount into Bureau of Engineering Fund No.100-78, Account No. 001010 (Salaries General), and to negotiate and execute any documents as may be needed for this purpose.
- 2. Instruct BOE to prepare any technical changes or additional Controller instructions that may be required to effectuate the intent of the Council action and authorize the Controller to implement said instructions.
